What Is The 2020 Census?

The 2020 Census counts every person living in the 50 states, District of Columbia, and five U.S. territories, only once, and in the right place. The 2020 Census is easy, confidential, and important.

Why is the Census Important?

Once a decade, America comes together to participate in the decennial census. This census provides the basis to:

- Reapportion Congressional seats
- Redraw state legislative districts
- Determine the amount of funding to state, county, & community programs
- Assist local governments in planning for public safety & emergency preparedness
- Help businesses decide where to locate new offices, stores & factories which create jobs.

During the 2020 Census, the Census Bureau will never ask you for:

- Your Social Security number
- Money or donations

- Your bank or credit card account numbers

Did you know....?

- As directed by Congress, **316** federal spending programs rely on data derived from the Decennial Census. Programs include: Medicare, schools, roads & highway planning, rural development, emergency assistance, youth assistance, programs for aging and the arts, to name just a few.
- In Fiscal Year (FY) 2017, these programs relied on 2010 Census-derived data to distribute **\$875 billion** to state and local governments, nonprofits, businesses, and households across the nation. This figure accounted for **7.8 percent** of Gross Domestic Product in FY2017.
- It is estimated that **25% of the population of Franklin County** went unaccounted for in 2010 due to individuals not completing the census.
- A study done by Georgetown University's Institute of Public Policy determined that monetary loss per person missed in the 2010 Census was **\$1,091/pp per year.**

Senate Bill 422 -- Reschedules the 2020 primary election from April 28 to June 2 with May 18 now being the last day to register to vote and May 26 the last day to sign up to vote by mail ballot.

Senate Bill 751 -- Waives the requirement for schools to be in session at least 180 days, provides for continuity of education plans, ensures school employees are paid during the closure, and provides the Secretary of Education with authority to waive student teacher and standardized assessments.

House Bill 68 -- Makes applying for unemployment compensation easier for workers affected by the COVID-19 pandemic. The bill requires the Department of Labor & Industry to waive the one week waiting period and job search and work registration requirements for claimants under the disaster emergency, provides automatic relief from benefit charges for employers whose account would otherwise be charged during the disaster emergency, increases timeframes and allows for interest-free payment plans, and provides the secretary with the ability to adopt temporary regulations to ensure compliance with federal law.

Letter Regarding Planned Parenthood -- Rep. Schemel joined more than other 50 representatives in signing a letter to the governor regarding Planned Parenthood continuing to perform elective abortions: despite the governor's COVID-19 order for all health care facilities to cease performing elective surgeries.

Request for Blood Donations -- According to the American Red Cross, there is a critical need for blood and platelets across the U.S. Many blood drives were canceled due to workplace and school COVID-19 closures. If you would like to donate blood, you can find the closest location at RedCrossBlood.org

Expiration Dates Extended -- Pennsylvania Department of Transportation (PennDOT) announced that all driver licenses, photo ID cards, vehicle registrations, safety inspections, emissions inspections and disability placards set to expire between March 16, 2020 and April 30, 2020 will will now be extended to May 31, 2020.

Procurement Portal -- Manufacturers, distributors and other suppliers can now get medical supplies to healthcare facilities more quickly through a new online procurement portal listing equipment needed to battle COVID-19. The list includes surgical masks, respirators, ventilators and other hospital supplies.

Real ID Date Extended -- The Department of Homeland Security has postponed the enforcement date for REAL ID from October 1, 2020, to October 1, 2021, in response to COVID-19 and the national emergency declaration.

Book of the Month

So often in life, we get stuck in a cycle of response. We put out fires. We deal with emergencies. We stay downstream, handling one problem after another, but we never make our way upstream to fix the systems that caused the problems. Cops chase robbers, and doctors treat patients with chronic diseases, and call-center reps address customer complaints. But crime and chronic disease and customer complaints are preventable! So why do our efforts skew so heavily toward reaction rather than prevention?





Upstream explores the psychological forces that push us downstream—including "problem blindness," which can leave us oblivious to serious problems in our midst. And Heath introduces us to the thinkers who have overcome these obstacles and scored massive victories by switching to an upstream mindset.

- One online travel website prevented 20 million customer service calls every year by making some simple tweaks to its booking system.
- A major urban school district cut its dropout rate in half after it figured out that it could predict which students would drop out—as early as the ninth grade.
- A European nation almost eliminated teenage alcohol and drug abuse by deliberately changing the nation's culture.
- And one EMS system accelerated the emergency-response time of its ambulances by using data to predict where 911 calls would emerge—and forward-deploying its ambulances to stand by in those areas!

Upstream delivers practical solutions for preventing problems rather than simply reacting to them. How many problems in our lives and in society are we tolerating simply because we've forgotten that we can fix them?

Genchi Genbutsu is a Japanese philosophy that means "go and see for yourself." Follow Malcolm Gladwell as he takes his car obsession to a new level, traveling to Japan to discover firsthand what makes the Lexus approach so unique.

Working from Home

Even before the social distancing recommendations and closures of physical offices due to COVID-19, working remotely is becoming a viable option for employers and employees. Here are a few resources to keep the engines running while away from the office

Chat / Instant messaging





Communication within the team can be the biggest challenge when your workforce is remote. Chat software like Slack and Microsoft Teams allow seamless communication between individual team members, departments and the entire company. Different chat "channels" allow people to discuss work, brainstorm ideas and stay connected to each other throughout the workday. Many companies already use these instant messaging tools, but you'll want to encourage your staff to pay extra attention to their messages right now, as this will likely become the primary method of communicating during your quarantine.



Video conferencing

Video meetings where the attendees can see each other's expressions and react to one another in real time can replicate the benefits of face-to-face meetings you would have had in the office. Video conferencing software typically includes screen-sharing capabilities, recording and live chat, which can add an extra layer of communication and understanding to your meetings. Popular choices include Google Hangouts and Zoom. [Ed. - Zoom is under question regarding security matters; use with caution.]



Cloud Storage

One of the challenges of working remotely is the lack of access to your company's internal servers. This is where cloud storage applications like Dropbox and Google Drive can come in handy. By moving all your files to the cloud, you ensure that your team has uninterrupted access to important documents, spreadsheets, presentations, videos and more. Plus, it's easier to collaborate in real time and avoid sending edited versions of documents back and forth.



Productivity and time trackers

When working from home, it can be easy to get off task — especially if employees are quarantined at home with their families. Productivity and time tracking apps like Toggl, Todoist and focus booster can help you balance your time, track your progress and remind you to take breaks. With your time being managed you can be more productive while working in a more comfortable environment.

Health Corner

Eye Health for Computer Users?

Recent research sponsored by The Vision Council has shown that 59 percent of people who routinely use computers and digital devices experience symptoms of digital eye strain (also called computer eye strain or computer vision syndrome).

CVS is similar to carpal tunnel syndrome and other repetitive motion injuries you might get at work. It happens because your eyes follow the same path over and over. And it can get worse the longer you continue the movement.

When you work at a computer, your eyes have to focus and refocus all the time. They move back and forth as you read. You may have to look down at papers and then back up to type. Your eyes react to images constantly moving and changing, shifting focus, sending rapidly varying images to the brain. All these jobs require a lot of effort from your eye muscles. And to make things worse, unlike a book or piece of paper, the screen adds contrast, flicker, and glare. What's more, it is proven that we blink far less frequently when using a computer, which causes the eyes to dry out and blur your vision periodically while working.



<u>Here are 10 easy steps</u> you can take to reduce your risk of eye strain and other common symptoms of computer vision syndrome (CVS):

- 1. Get a comprehensive eye exam.
- 2. Use proper lighting.
- 3. Minimize glare.
- 4. Upgrade your display.
- 5. Adjust your computer display settings.
- 6. Blink more often.
- 7. Exercise your eyes.
- 8. Take frequent breaks.
- 9. Modify your workstation.
- 10. Consider computer glasses.
