

The House and Senate recently approved legislation that would base restaurant capacity on guidance from the federal Centers for Disease Control and Prevention, rather than directives from the governor's office. House Bill 2513, which now heads to the governor's desk, would allow restaurants to operate at 50% capacity with the ability to operate above that if the guidelines issued by the CDC and the Commonwealth allow, or if they maintain physical barriers between customers. Bar service would also be allowed once again under the legislation. I don't believe that the state should mandate any restrictions on facility capacity, but I did vote in favor of the legislation as the best of bad options.



Last week, the Pennsylvania Supreme Court issued a decision allowing for <u>mail-in ballots</u> to be accepted by election boards for up to three days following Election Day. This decision ignores the federal and state constitutions and jeopardizes the security and integrity of our elections. Ultimately, Pennsylvania could be put in the middle of a disastrous national crisis as the country waits for our state to tally election results for days or weeks following Election Day.



The Pennsylvania Department of Labor & Industry (L&I) announced that due to an alarming spike in suspicious applications for unemployment benefits through the Pandemic Unemployment Assistance (PUA) program, additional anti-fraud and identity verification measures will be put in place. Because of that, payments for new applicants are being temporarily delayed with the department providing more information as the enhancement continues. There is no effect on people who have already opened a PUA claim.


In recognition of the 19th anniversary of the September 11 terrorist attacks, the Senate voted to observe a moment of silence in schools to honor our fellow Americans who lost their lives on that fateful day. Senate Bill 869 also will ensure model curriculum is developed to help students understand the significance of these attacks in our nation's history. In addition, the bill would create a similar moment of silence in recognition of Pearl Harbor Day on December 7.



The Senate approved <u>Bill 1281</u> which will rebrand the state's "Steer Clear Law" as the "Move Over Law" to ensure motorists know how to react when approaching an emergency response area. The legislation would better protect law enforcement, fire and EMS personnel, tow truck drivers and other emergency responders. The measure also increases fines and points for violations and boosts public awareness of the responsibilities of motorists approaching an accident scene.

Bill Freezing Pay for PA's Top Executive Branches Headed to Governor's Desk

"Legislation is on its way to Gov. Tom Wolf's desk that would not only freeze lawmakers' salaries at their current level through 2021 but judges and top executive branch officials as well. Mr. Wolf has signaled that he will sign it into law, his spokeswoman Lyndsay Kensinger said.

The bill, sponsored by Rep. Frank Ryan, R-Lebanon, was offered in recognition of the economic hardships that COVID-19 has had on the commonwealth as well as its citizens and businesses, causing massive amounts of job losses and forcing some businesses and restaurants to close permanently. "When Pennsylvania residents are making sacrifices and struggling just to put food on their table, it is no time for public officials to be taking a raise," Mr. Ryan has said. The bill passed the Senate recently by a 48-0 vote. It passed the House in May by a 202-0 vote. More on this from the Pittsburgh Post Gazette.



IRS Issues Notice on Payroll Tax Deferral

"Recently, the IRS released its first notice regarding implementation of the president's executive order on payroll tax deferral. Employers may suspend the withholding of the 6.2% Social Security payroll tax normally deducted from an employee's pay. "The deferral only applies if the biweekly compensation (or equivalent amount for other pay periods) is less than \$4,000. The determination of whether the deferral applies is made on a paycheck to paycheck basis.


"The deferral only applies to wages paid during the period beginning on September 1, 2020 and ending on December 31, 2020. "Employers are responsible for withholding and paying any deferred taxes. Specifically, employers "must withhold and pay the total Applicable Taxes that the [employer] deferred under this notice ratably from wages and compensation paid between January 1, 2021 and April 30, 2021 or interest, penalties, and additions to tax will begin to accrue on May 1, 2021, with respect to any unpaid Applicable Taxes."
