- All booth assignments will be made on a first come/first served basis by order of receipt of full payment.
- No vendor may sublet or apportion space in whole or in part w/o committee approval.
- No refunds will be granted. Sidewalk Days is a rain or shine event.
- The Chamber does not provide canopy, tables, or insurance.
- Each vendor is responsible for their own trash removal. All waste produced by your service shall be disposed of in your own sealed trash container per Pennsylvania state guidelines. \$10.00 fee will be charged for spaces left untidy.
- There will be an onsite inspection by the PA Department of Agriculture during the event. You are solely responsible for meeting PA Department regulations, and if those regulations are not met, your participation in the event will be terminated with no refund or recourse against the Greencastle-Antrim Chamber of Commerce.
